



# Saturday 30th November 2019 Main points from the latest NZCHA Council Meeting.

- NZCHA have decided to produce their own rule book. Members will be able to download it council is investigating the cost of printing hard copies.
- Second Futurity Event Clubs have been approached re interest in running a Futurity event at one of their shows in conjunction with the NZCHA. \$500 sponsorship. Proposals put forward will go to the next AGM.
- Clubs are allowed to run aged events.
- Chatter editor motion from previous meeting was rescinded payment to stay the same until the 2020 AGM. It will then become a non payment portfolio position. Secre/Treas. will receive \$600 each per annum.
- Discussion on giving out Hi Point NZ awards such as buckles. Councils though it might encourage members to support the shows where they have to travel a long way. It was decided to leave it as it is.
- Olivia put her membership remit proposal forward to be approved by council before going to the AGM.
- Open Snaffle bit Proposal This is to help beginners any horse/rider combo. Same combo cannot enter hands down at same show. Clubs to include it in their show programme if they can.
- National Finals venue is the same as last year, house is available. Show 4/5thApril.
- AGM 2020 will not be held at the finals. It will be held on the last weekend of June, venue to be announced.
- Helen was given permission to review the constitution for inconsistencies and also to review the portfolio documents.
- Portfolio holders to give a report at the AGM.
- Craig asked Councillors if they could make more effort to come to the meetings in person as video calling is difficult.
- Discussion on utilising judges. Form to be sent to judges to check availability.
- Next Council meeting will be held mid week in February date to be finalised.
