Bar Bees Playboy (by Karen Matchitt)



AKA Ken (Yellow Unicorn/Kenny Penny) to his friends, was born on the 19th November 2006, his dam is Hollywood Bar Bee and sire is Kings Playboy (imp) Bred by Harold & Maria Morrissey of Taumarunui.

I first met Ken when he was a foal still on his mum before he had his accident when a helicopter scared him down a hill and into a fence, he will always bear the scars of that accident on his face and hind legs, his scars only add character and uniqueness.

When Ken was a two year and being travelled around the shows for experience, I got to have my first ride on him, never thinking he would one day be my horse. At Taumarunui A&P show cutting, I was competing on Nickel Bar, but we were seriously short of help horses,

so Harold asked me to be herd help on the very young, newly broke Ken, no pressure. During a competitors run a plastic shopping bag flew over the fence hit Ken in the head and landed under his belly, he stood rock solid just turning his head to watch the bag,

what was I meant to do now, being a rookie new to cutting I didn't know if I should jump of the horse and grab the bag, or would that freak out Ken and ruin the run that was in process? Luckily the buzzer went, and Harold was able to come to my rescue and retrieve the bag, so Ken could move.

Ken went to his Futurity in 2010 the first time it was held at Hawera, Judged by Graeme McInnes and Craig Laird. Harold was fortunate to even get him there, after not being able to find Ken in the paddock a week prior to the futurity, on searching the property, he was found upside down in a drain a few paddocks away. How he got there, no one knows. He survived the ordeal and won the futurity. Graeme told me years later that when he judged him, he had the best stop he'd seen in the cutting pen in a long time.

Ken wasn't shown again in 2010-11, as life just got in the road for Harold, he came out to a few shows in 2011-12 and achieved runner up National Hi Pt Novice horse. In Feb 2013 I was giving away cutting until Harold phoned me and told me to come and get Ken and take him to Sitemans Show, as he was just sitting in a paddock going to waste. With arrangements made Ken had a week's work and new shoes, loaded onto a strange float, and headed off for a show. Harold rode him in the Open Horse, so I could see how to ride him, then it was over to me for my Rookie and Ladies runs, he won both, I was super happy. After the show the cattle had to be moved back up the road, so I took Ken along for the ride, the cattle had their own thoughts as to where and how they would head back up the road, which ended with Ken and I up the banks and in the bushes, he went wherever I asked him to go, I even managed to get him stuck with branches trapping his legs and he couldn't move forward, he didn't panic, just waited patiently for me to come up with a plan to back out of our trap. When I finally got back to the floats, I was certain Ken was coming home with me, he made me feel very safe.

Since then, Ken has been super consistent in the show pen, even giving Jacob and Olivia a memorable season of wins and trophies, then taking Mindy from a very Novice Rookie up to Open Non pro in a few seasons. I might not have buckles and trophies on Ken, but I'm super proud to be his owner and love watching him go out and give his all. I have heard people say to his riders "oh you don't have to worry your riding Ken". The truth is Ken is not silly, if you don't ride, use your legs, watch the cow, stay in the moment, he will feel it and question you to "Who is in control here". If you aren't confident and ride with purpose, Ken will be more than happy to give you a pony ride and plod around.

There also aren't many competitive cutting horses that can multitask like Ken, he can be winning a class, then turning back or herd helping, then doing a very respectable Western dressage test, a reining, or doing connexion challenges with international riders, and letting pony club kids and newbies experience a ride on a cutting horse. Quite a few Pony Club parents have asked if they can buy him, because he is so gentle, well mannered, and safe for children, qualities they look for but are difficult to find. A lot of Kens attributes come from his dad "Kings Playboy" and the grounding and training that Harold Morrissey put into him.

We have so many more stories of Kens life with us, but they would take a large book to tell.

As a youngster he showed all the moves of a great horse. Maria and the kids found this out one day when they were trying to catch him, they ended up having to chase him into a stable. They weren't very impressed.

He was a very easy horse to start, train and be around. But also had a pretty tough, side to him as well. He is an extremely cowy horse so training for the futurity progressed easily.

Ken has always been the sort of horse you could feel confident with no matter what cow was in front of you.

I entered him into the 2010 NZCHA Futurity, winning the Open Futurity and the Non Pro Futurity. It was in the futurity that being able to handle a tough cow really paid off. The following season he was a really, great competitive horse achieving Reserve Hi Point Novice horse.

Unfortunately, he never made the National Derby due to a minor injury.

During the next season he was sold to Karen Matchitt, ending a great season for her with the North Island High Point Ladies title.



Section 47 of Incorporated Societies Act 2022 Qualifications of officers

- (1) Every officer of a society must be a natural person.
- (2) A natural person who is not disqualified by subsection (3) may be elected or appointed as an officer of the society, so long as that person—
 - (a) **has consented in writing to be an officer; and**
 - (b) certifies that they are not disqualified from being elected or appointed or otherwise holding office as an officer of the society.
- (3) The following persons are disqualified from being elected or appointed or otherwise holding office as an officer of a society:
 - (a) a person who is under 16 years of age:
 - (b) a person who is an undischarged bankrupt:
 - (c) a person who is prohibited from being a director or promoter of, or being concerned or taking part in the management of, an incorporated or unincorporated body under the Companies Act 1993, the Financial Markets Conduct Act 2013, or the Takeovers Act 1993:

 - (d) a person who is disqualified from being an officer of a charitable entity under section 31(4)(b) of the Charities Act 2005:
 - (e) a person who has been convicted of any of the following, and has been sentenced for the offence, **within the last 7 years:**
 - (i) an offence under subpart 6 of Part 4:
 - (ii) a crime involving dishonesty (within the meaning of section 2(1) of the Crimes Act 1961)
 - (iii) an offence under section 143B of the Tax Administration Act 1994:
 - (iv) an offence under section 22(2):
 - (v) an offence, in a country, State, or territory other than New Zealand, that is substantially similar to an offence specified in sub-paragraphs (i) to (iv):
 - (vi) a money laundering offence or an offence relating to the financing of terrorism, whether in New Zealand or elsewhere:
 - (f) a person who is subject to any of the following orders:
 - (i) a banning order under subpart 7 of Part 4:
 - (ii) an order under section 108 of the Credit Contracts and Consumer Finance Act 2003:
 - (iii) a forfeiture order under the Criminal Proceeds (Recovery) Act 2009:
 - (iv) a property order made under the Protection of Personal and Property Rights Act 1988, or whose property is managed by a trustee corporation under section 32 of that Act:
 - (g) a person who is subject to an order that is substantially similar to an order referred to in paragraph
 - (f) under a law of a country, State, or territory outside New Zealand that is a country, State, or territory prescribed by the regulations:
 - (h) in relation to any particular society, a person who does not comply with any qualifications for officers contained in the society's constitution.
- (4) A natural person who is disqualified from being an officer but who acts as an officer is an officer for the purposes of a provision of this Act that imposes a duty or an obligation on an officer.
